**Do we use ‘cookies’?**

Yes. Cookies are small files that a site or its service provider transfers to your computer’s hard drive through your Web browser (if you allow) that enables the site’s or service provider’s systems to recognize your browser and capture and remember certain information. ## **Username, Passwords, and Profiles**

### **One-On-One Programs:**

With group sessions, missed sessions will not be compensated in any way or form.
